The governor's budget proposal to limit further cuts to schools in 2011-12 is dependent on voter approval of an extension of existing temporary tax increases and a ballot measure to extend temporary revenues will help prevent further cuts to schools.

8.2 Adopt Resolution # 11-2, Allowing the Santa Cruz County Superintendent of Schools to temporarily loan cash to Santa Cruz County School Districts

Pursuant to Education Codes 42621 and 42622, the County Superintendent of Schools, with the approval of the County Board of Education, may make temporary transfers to any school district which does not have sufficient money to its credit to meet current operating expenses.
